
ATG Insures \$115 Million Transaction Largest Multi-Residential Sale In Champaign County History



In 2022, Advocus then known as Attorneys' Title Guaranty Fund, Inc. (ATG®), as agent of First American Title Insurance Company, insured a \$115 million transaction, the largest multi-residential sale in Champaign County history. The transaction involved multiple residential buildings on or around Green Street, the heart of Champaign's "Campustown." The properties were amassed over a 60-year period by the late Leon Bankier in his long career as a real estate investor. The portfolio was held in the Leon Bankier Family Limited Partnership and was acquired by R2 Companies and Concord Capital Partners late in 2021. The transaction included 35 properties, 580 residential units, more than 80,000 square feet of retail, and four assemblage sites for future development. The academically-oriented student communities represent 1,323 beds for University of Illinois students and are loaded with security-based and studentlifestyle amenities.
