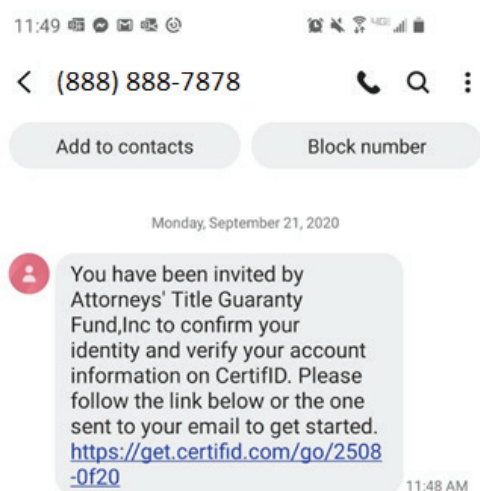

CertifID will contact you, the seller, by text or email to verify your identity and wire instructions.

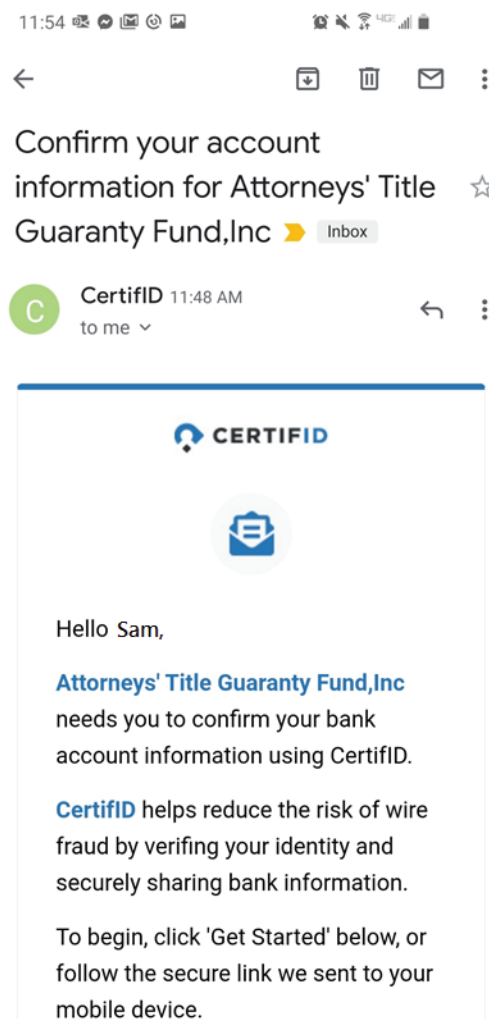
