Prices subject to change.) Guests may drop passengers off at Entrance 2

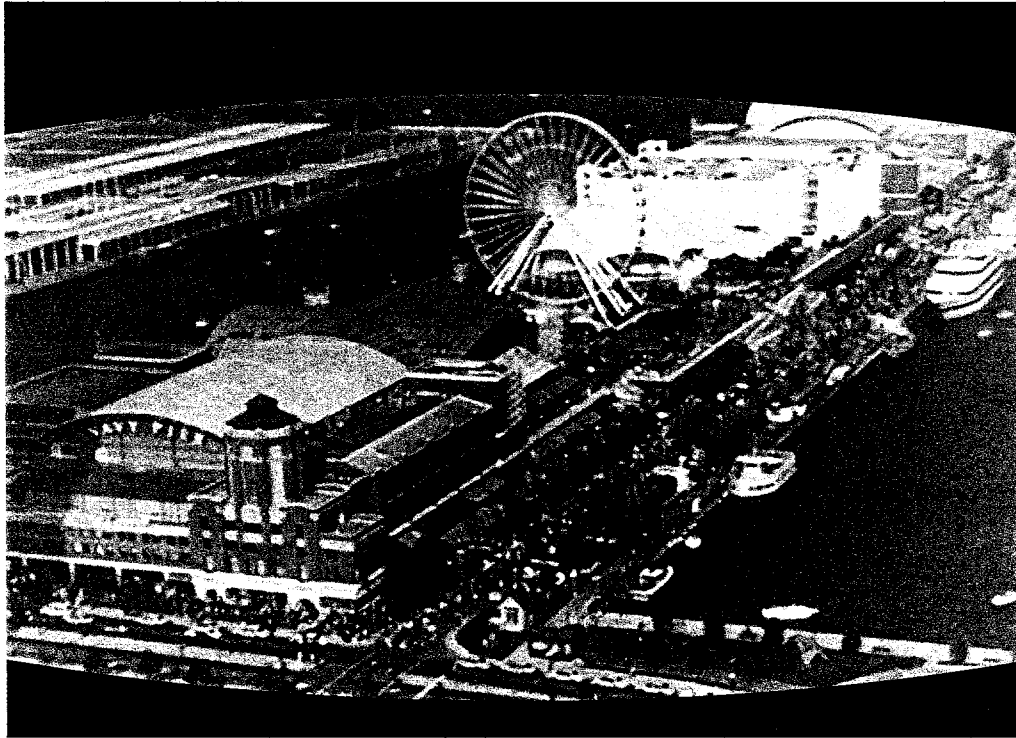
(located on the north side) before proceeding to the parking garage.
